

Continuing Push for Retiree Benefit Increase During 2024 Regular Legislative Session

ARSEA/APEAL placed much of its focus during the 2024 regular session on passing legislation that allows the Legislature to award regular benefit increases to state government retirees and provides local governments the option of providing identical enhancements to their retirees.

After a three-year effort of drafting the legislation and educating lawmakers on its need, House Bill 201, sponsored by State Rep. Steve Clouse (R - Ozark) and carried by Sen. Clyde Chambliss (R - Prattville), received unanimous passage in the Alabama House and, as this issue of the Advantage goes to press, awaits consideration in the Finance and Taxation General Fund Committee.

The measure conceived of by ARSEA/APEAL President-Elect Norris Green, retired director of the Legislative Fiscal Office, provides benefit increases on a pay-as-you-go basis funded through state agencies rather than placing an unfunded mandate on the Retirement Systems of Alabama, as previous cost-of-living adjustments demanded.

Grassroots legislative contacts made by our members repeatedly noted to lawmakers that retirees have not received a benefit increase since 2006 while inflation has skyrocketed.

While HB201 remains under consideration, companion bills that would have authorized a 3% benefit increase under the new system were unable to pass after being caught behind a backlog of state budgets and other priority legislation. We appreciate Sen. Kirk Hatcher (D-Montgomery) and Rep. Randall Shedd (R - Fairview) for their sponsorship of the bills.

Though our benefit increase bill does not require new funding, members of the legislative leadership have indicated they would like to tie its passage to potential revenues from gaming legislation being negotiated by a conference committee after the House and Senate passed differing versions of the bill.

We have traditionally supported lottery and gaming bills that benefit the General Fund and can provide additional money for retirement and health insurance benefits for retirees.

We remain fully committed to our legislation, and if the 2024 regular session adjourns prior to its passage, we will introduce it again and again for as long as it takes to provide our members with the benefit increases they need and deserve.







Vote for Norris Green ERS Board of Control

Citing his stellar service, experience, and strong commitment to fiscal responsibility, ARSEA/APEAL has nominated Norris Green for a new term as the state retiree representative on the Employees' Retirement System Board of Control.

Green spearheaded the effort to secure regular benefit increases for state and local retirees, and he has developed COLA legislation



that would allow the lawmakers to resume the practice without adversely affecting the finances of the Retirement Systems of Alabama. His bill received unanimous passage in the Alabama House during the 2024 regular session.

Joining ARSEA/APEAL within a month after retiring with 39 years of service, Green served as the director of the Legislative Fiscal Office, where he handled all legislation related to RSA. His vast knowledge and experience in dealing with the multi-billion-dollar Education Trust Fund and General Fund budgets has served him well as a member of the ERS board that oversees almost \$15 billion in assets.

"Norris Green has stood tall as the state retiree representative on the ERS Board, and he has always voted in the best interests of the retirement system and the members it serves," ARSEA/APEAL President Thomas Moore said. "Dr. Bronner and the other member representatives on the ERS board have a strong and committed ally in Norris, and we are proud to nominate him for a new term."

Look for your official ballot from the Retirement Systems of Alabama in the coming weeks.

Annual Legislative Day and Reception

ARSEA/APEAL held its annual Legislative Day at the State House in March as members and leaders from across Alabama gathered in Montgomery to personally lobby lawmakers on behalf of our retiree benefit increase legislation.

Members informed their lawmakers about the need for ARSEA/APEAL's bill to create a new process to provide retiree benefit increases. President-Elect Norris Green, who retired as the director of the Legislative Fiscal Office, was on hand to provide legislators with details on the "pay-as-you-go" proposal that requires the Legislature to fund the annual cost of benefit increases upfront, which avoids additional stress on RSA.

In addition to the retiree benefit increase bill, ARSEA/APEAL members lobbied for the full funding request of the State Employees Health Insurance Program, which provides retiree healthcare coverage.

The event concluded with a legislative reception sponsored by our Friends of Retirees and Employees Political Action Committee at the RSA Plaza and attracted Speaker of the House Nathaniel Ledbetter (R - Rainsville), prominent legislative committee chairs, and several lawmakers from both sides of the aisle.

The annual State House visits are important to allow legislators to put a human face on the fiscal issues they must tackle and to remind them that the budgets are more than just figures on a spreadsheet – each decision they make dramatically affects the lives and finances of thousands of our members across Alabama.

We appreciate everyone who took the time to join our lobbying effort in Montgomery as nothing is more effective in passing legislation than the personal, one-on-one request of voters from a lawmaker's home district.



PRESIDENT-ELECT Thera Herring

Before retiring in 1995 with 25 years of service, Thera Herring was employed as the Director of Facility Based Services for the Alabama Medicaid Agency and previously held roles at the Department of Pensions and Security. She later started a consulting firm, Healthcare Compensation Solutions, which contracted with the Departments of Public

Health and Human Resources. In recent years, Herring has worked with the nursing home industry to conduct educational seminars to assist Alabama's elder population navigate complex Medicaid eligibility guidelines.

A Prattville resident, Herring has been an active member for several years and is also involved in the Auburn University Club and Daughters of American Revolution.

Herring currently serves on the ARSEA/APEAL board as Vice-President South Central



VICE PRESIDENT NORTH Peggy Harris

Peggy Harris retired from the Alabama Cooperative Extension Service as a County Extension Agent in 1995 with 31 years of service. Following her retirement, Harris served for three terms as president and executive board member of the Pilot Club of Cullman and played a role in establishing the local United Way, Hospice of Cullman

County, and Cullman City Tree Commission. She is a member of the Commission on Aging Advisory Board, where she helped organize a county-wide transportation system.

Harris served for 29 years as a member and officer of the Cullman chapters of the National Association of Federal Employees (NARFE) and ARSEA/APEAL. She served several years on the ARSEA Foundation Board and the ARSEA/APEAL Board of Directors. She was inducted into the Alabama Senior Citizens' Hall of Fame in 2023.



VICE PRESIDENT SOUTH CENTRAL Carolyn Middleton

Carolyn Middleton retired as Alabama's state budget officer in the Department of Finance in 2013 with 40 years of service and has served as a retiree representative on the State Employees' Insurance Board since 2015. Among her Executive Budget Office duties were analyzing the General Fund and Education Trust Fund budgets,

making revenue estimates, preparing legislation, and as chair of the First Readings Committee.

In retirement, Middleton volunteers for Medical Outreach Ministries, is a member of the American Society of Certified Public Managers, the Montgomery Museum of Fine Arts, Auburn University Montgomery Alumni Association.

The National Association of State Budget Officers honored Middleton as the 2006 "State Budget Officer of the Year." She was inducted into the Alabama Senior Citizens' Hall of Fame in 2023. Middleton currently serves on the ARSEA/APEAL Board as an Ex-Officio member as one of two SEIB representatives.



SECRETARY-TREASURER Thomas Moore

Thomas Moore retired from the Alabama Department of Revenue as an income tax examiner with 25 years of service in 2006. Since retirement, he has been involved with the Alabama Tombigbee Regional Commission and the Rural Health Medical Program.

A past member and chairman of the Demopolis City School Board, Moore served as a councilman for the City of Demopolis and was president of the Alabama League of Municipalities in 2011.

He represented District 9 on the ARSEA/APEAL board of directors for two terms and served as vice president of the association's South-Central Region before his election as state president. His term as ARSEA/APEAL President will end on July 1, 2024.

DISTRICT 5 (Baldwin) Ralph Hellmich

Ralph Hellmich was elected mayor of the City of Foley in 2020 after serving 16 years as a member of the city council. He retired from the State Oil and Gas Board, where he served as the Regional Operations Supervisor responsible for overseeing operations in the southern half of Alabama, in 2019 with 39 years of service. Hellmich currently serves as chairman of the board for Riviera Utilities and is a past member of the Foley Planning Commission. He is a lifetime member of the Wolf Bay Watershed Watch and the president-elect for the University of Alabama Geological Sciences Advisory Board.

Hellmich currently serves on the ARSEA/ APEAL Board of Directors representing District 5.



DISTRICT 11 (Chambers, Lee, Macon, Russell, Tallapoosa) Joe Lovvorn

Joe Lovvorn retired as a firefighter with the City of Auburn in 2021 after rising through the ranks during his career to serve as team leader, lieutenant, and, eventually, battalion chief. He has been a member since 2021.

In 2016, he was elected to represent House District 79 and currently serves as chairman of the powerful, agenda-setting Rules Committee, which determines what bills and measures are up for consideration each legislative day.

Lovvorn owns Two Men and a Truck, a moving company servicing Auburn and Montgomery, and is a board member of the Auburn Chamber of Commerce.



DISTRICT 7 (Butler, Coffee, Pike, Covington, Crenshaw) Crys Fuller

Mary Crystal "Crys" Fuller of Kinston retired from the district attorney's office in Enterprise, where she continues to work part-time, in 2020 and immediately joined ARSEA/APEAL. She began her career as a clerk with the Alabama Department of Industrial Relations in 1991 and held positions in the Department of Transportation and the Coffee County Sheriff's Office and went on to work at the District Attorney's Office.

Fuller also has private-sector experience in banking and lending and, as a retiree, event venue management.

She currently serves on the ARSEA/ APEAL Board representing District 7.



DISTRICT 9 (Choctaw, Greene, Hale, Marengo, Sumter) LeTonya Williams

LeTonya Williams retired from the Alabama Tombigbee Regional Commission in 2022 with 27 years of service and previously worked for seven years in the Demopolis Police Department. She has been a member since 2022.

She is the founder of a clothes closet program that provides new and gently used clothing to needy children in the school system and is a member of the Morning Star Baptist Church in Demopolis, where she serves on the hospitality committee. Williams is recently widowed and has two daughters.



DISTRICT 17 (Cullman, Lawrence, Morgan) Proncey Robertson

Proncey Robertson retired in 2018 after 26 years of service as a police officer in the City of Decatur, where he served as a liaison to the Department of Homeland Security, pioneered school protection plans against active shooter attacks, and operated as a member of the SWAT team. In 2003 he was selected as the American Legion's "Law Enforcement Officer of the Year" in Alabama.

A long-time supporter and advocate of the Special Olympics, Robertson was inducted into the Alabama Law Enforcement Torch Run for Special Olympics Hall of Fame in 2015.

Robertson was elected in 2018 and served one term to represent House District 7 during which time was a strong advocate for state and local government retirement benefits.



DISTRICT 18 (Madison) Mark Clouser

Mark Clouser has been a member since 2021. He retired from the City of Huntsville Fire and Rescue in 2022 with 32 years of service. Holding the title of district fire chief at the time of his retirement, he previously served as captain for 18 years in the North Parkway location.

Clouser is a graduate of Calhoun Community College, the University of Alabama in Huntsville, and the Alabama Fire College.

He and his wife, Margaret, have been married 40 years and have two children and two grandchildren.

Clouser currently serves as the District 18 FOREPAC DAC.
